Risk, Release, and Informed Consent: I agree that by signing below as a parent or guardian of a participant who is under the age of 18 years, I acknowledge that there are risks and hazards inherent in the Highwood Outdoor Pool Day Camp to which I am willing to expose my child or charge. By signing below, I also give written consent for my child to participate in the activities of the Highwood Outdoor Pool Day Camp. I understand that reasonable precautions and safety measures will be taken by the pool and camp staff and I agree to release and indemnify the Highwood Outdoor Pool / Day Camp, its employees and volunteers from any claims for loss, injury, illness to persons and property however caused, while participating in the chosen activity, which I, or any person claiming through me on my behalf, may at any time have, arising out of or connected with the operation of said activity.

Medical Services: In case of emergency or illness, every effort will be made to contact the parents or guardians. In the event that contact cannot be made, I agree that in case of emergency or illness, qualified medical personnel may attend to my child. I agree that I will be financially responsible for medical advice or services secured as necessary for the health and safety of my child.

Medication Policy: Due to the short time children are present at camp, medication WILL NOT be administered. If an emergency situation demands medication, (IE Ventalin, or EpiPen) It will be administered with the permission of the parent/ guardian signing below. Emergency medication MUST be clearly labeled and in the original container and handed to a SR Day Camp Leader.

Refund Policy: If our program is cancelled for any reason by Highwood Outdoor Pool, your child may transfer to another week that is running, or receive a full refund with no admin fee attached. With minimum notice of 72 hrs before camp starts, a \$25.00 admin fee will be charged and balance of camp fee returned by community cheque. Less than 72 hrs notice and once camp has started a \$25.00 admin fee is charged as well as the number of camp days passed prior to written notice being received by SR camp staff. There are no refunds given due to bad weather.

Transfers: Campers may change from one type of camp to another in the same week upon availability. If hours are increased extra time will be charged. No refunds for decrease of full to 1/2 day.

Medical Refunds: Withdrawals and transfers are given with no penalty prior to start of camp with a Dr.'s note. After start with a Dr.'s note, refund or transfer will be prorated and have no admin fee.

Photo Release Agreement: The undersigned hereby grants Highwood Outdoor Pool Day Camp permission to take and publish still photographs and moving videos or publish those previously taken of my child. This media will remain the property of and may be used by Highwood Outdoor Pool Day Camp for the purpose of displays and promotion with no compensation to me or my child.

Travel Permission: I understand this program may include outings to locations on different premises than the primary camp location. I grant permission to include my child in these walking outings.

Drop-off & Pick-up: Parents will be given a 15 minute grace for drop off or pick-up times. Those arriving outside of those times will be charged the before or after care fee. Parents are asked not to drop off or leave children unattended outside the pool, hall, park, or playground. They must be signed in and out of care each day unless alternate arrangements have been made.

Parents are also asked to ensure children arrive promptly for camp start. This will enable leaders to better plan activities, crafts and swim times.

Sunscreen / Insect Repellent: Participants are responsible for providing & applying their own sunscreen and insect repellent. Please send to camp in original container with child's name on it.

Understand All (Including Refund Policies): I have asked any questions I have about the camp's policies and operations.. All questions about policies & operations have been answered to my satisfaction. I understand that all refunds will be made by community cheque only. No cash refunds will be made through the pool office.
